

**Bearville Township

October 10, 2023**

The Bearville Town Board of Supervisors' meeting was called to order at 6:40 pm by Chair Gene Baker with Supervisors Janelle Driscoll and Mike Laulunen, Jemma Baker, Treasurer and Clerk Kathy Cressy present. Also, present- Dustin Nelson- Fire Chief.

Baker made a motion to approve the minutes of the September 12, 2023 board meeting and accept the October 10th agenda with the addition of road inspection report (brushing) and roof repair. Driscoll seconded. AIF Motion Carried.

Laulunen reported that he drove down Cedar Lane and there had been a big Red Pine down across the road. Thinks it was on the State Park easement. Looks like someone had cut it off the road.

HALL

Furnace check at the hall was completed- everything good. Liberty Heating also checked the old unit in the fire hall, wondered about fixing it. He will give us a quote. Asked about the heater under the town hall floor, is there a way for us to get notification if the heater is not working? Baker will check out the heater under the floor.

FIRE

Chief Nelson reported 3 calls this month. The dump valve on the tender was replaced. Nelson reported that he went and looked at the State surplus trucks in Willow River. They found a slip in to go in the truck quoted at \$12,000.00. It has 94,000 miles on it and is an F350 Ford diesel.

Baker made a motion to purchase the Ford F350 diesel (2011) for \$12,000.00 at Nelson's discretion. Driscoll seconded. AIF motion carried.

Baker made a motion to purchase a Boss plow for up to \$9095.00 Driscoll seconded. AIF motion carried.

Overhead Door came out to look at the track- it was good. They recommended a professional residential at \$700.00 for the apron and rail.

Baker made a motion to replace the door opener for \$700.00 Driscoll seconded. AIF motion carried.

Fire extinguisher check is being held on October 21st from 10am – 1pm

Driscoll made a motion to have snacks, donuts and drinks at the fire extinguisher check to spend up to \$50. Baker seconded. AIF motion carried.

Baker made a motion to accept the fire report, Driscoll seconded. AIF motion carried.
