

**Bearville Township  
Board of Supervisors Meeting  
August 6, 2024**

The Bearville Town Board of Supervisors' meeting was called to order at 6:35 pm by Chair Gene Baker with Supervisor Janelle Driscoll, Supervisor Mike Laulunen, Treasurer Jemma Baker, and Clerk Kathy Cressy and Dustin Nelson, Fire Chief present.

GBaker made a motion to approve the 8/6/24 consent agenda, (the 7/9/24 minutes and 8/6/24 agenda with the addition of signage for road closures) as read. Driscoll seconded. AIF motion carried.

**FINANCIAL REPORT**

Receipts: \$430.00 from the State of Minnesota for Training and Education grant, \$4,647.50 from St. Louis County for 2<sup>nd</sup> half 2024 fire contract, \$800.00 from Mlaker Funeral Home for S. Mueller burial.

JBaker reported a transfer of \$15,599.35 from ARPA Fund to the General Fund for kitchen, electronics and technology (security system).

Laulunen made a motion to review and pay claims. Driscoll seconded. AIF Motion carried.

GBaker made a motion to accept the financial report. Driscoll seconded. AIF Motion carried.

**GENERAL:**

Driscoll made a motion and GBaker seconded to authorize Laulunen to order 8 Type II barricades and, water over the road signs, and road closed signs for up to \$2000.00. AIF motion carried.

Dustin Nelson, Fire Chief reported 1 call during the month, 911 power outage due to the CrowdStrike incident. They are still working on getting the ID cards.

Larry Salmela, Carpenter Town Supervisor sent GBaker a lease suggestion that he received from their lawyer. It did not appear that the Carpenter or Bearville board had any input. Item tabled.

Laulunen made a motion to accept the Fire Report. GBaker seconded. AIF motion carried.

**CEMETERY:**

Laulunen met with T. Bormann at the cemetery. There are some sunken graves so we might want to get some fill. There is also a big tree with what looks like a rotten core. We will get some tree service quotes and ask if MCF-Togo Incarcerated People could do some of the work.

**NEW BUSINESS**

Laulunen reported there was some graffiti on the Bridge in South Bearville. He contacted Itasca County, and it has been taken care of.
